**CNR Announces Closing of Units Offering**

NEW YORK - (MARKETWIRE) — May 11, 2011 — China Metro-Rural Holdings Limited (NYSE Amex: CNR) is pleased to announce that it has closed an underwritten public offering of 1,517,978 units at a price to the public of \$2.88 per unit. The offering yielded gross proceeds (before the underwriting discount and commissions and estimated offering expenses) of approximately \$4.37 million. Each unit consists of one of CNR's ordinary shares and a warrant to purchase 0.65 of one of CNR's ordinary shares. The exercise price of the warrants is \$3.456 per ordinary share, subject to certain adjustments.

CNR intends to use the proceeds of the offering for the acquisition of land use rights for China Northeast Logistics City – Dezhou, additional capital for Phase II construction of China Northeast Logistics City – Tieling and for general corporate purposes.

Maxim Group LLC acted as the sole underwriter of the offering.

The offering was made pursuant to the Company's existing shelf registration statement, which has been filed with and declared effective by the Securities and Exchange Commission.
